Climb and Maintain Flight Level 55

For those of you who were not able to make the recent talk given by Terry Lutz about his experiences at Airbus, there may be a way for you to see this presentation. Bill Bezdek, who came up with the original idea of having Terry as a "guest" speaker, has also videotaped the entire presentation. Maybe if we speak to him real nice, he would bring it to the meeting on Saturday and show it for those who couldn't make the original presentation. If you haven't been keeping up with Terry's exploits, he recently landed the first Airbus A380 with about 550 souls on board at JFK Airport in New York. It was quite a momentous occasion since he was the very first pilot to land this craft in the USA. Terry was also gracious enough to present the Chapter with a framed photograph of the landing signed by him and noting the date and other specifics of the flight.

Board of Directors Meeting, April 11, 2007

Bill Purosky called the Board meeting to order at 7:35pm. Attendees: Bill Purosky, Dave & Debbie Groh, Doug Koons, Vickie Vandenberg represented by proxy, Bill Bezdek, Tom Botsford and Del Johnson. Proxy designees Tom Botsford and Doug Koons represented Chuck and Sharron Hacker, respectively.

- The minutes were approved as published in the newsletter.
- Doug Koons reported an end of March balance of \$15,902 and a net income of -\$577. The treasurer's report was approved.
- Doug also reported that Fred Honhart is personally planning on flying a Scout troop, out of Alma, that are working on merit badges. If the Chapter is to register these flights under the Young Eagles program we will need dates and times so that we can meet the EAA insurance and reporting requirements.
- Bill Bezdek reported on the Dayton trip. Everyone had a good time and all returned home safely.
- Doug reported that the light covers cost between \$85 and \$90 for materials.
- Bill Purosky reported that Doug Simons has moved his plane out of the hanger and has requested a partial refund. After discussions it was decided that we would follow the stated terms of the contract and not award any refund for the unused portion of the month rental.
- The Mason Aviation Day event was discussed including the proposed budget.
- Bill Purosky reported that Pat Salow is finishing up his airplane and will need to work with a Flight Advisor. Bill will contact other Chapters to see if they have a Flight Advisor that can help since Terry Lutz is out of the country.
- An Airport Advisory Group is being formed by CRAA to provide input to the development of rules and regulations for Mason airport. CRAA

wants to limit the group to no more than six. Bill Purosky is seeking a seat on the committee and will represent Spartan Wings. Joe Pirch is also requesting a position on the committee and can represent Chapter 55. →The Board meeting adjourned at 9:35pm.

Business Meeting, April 14, 2007

Bill Purosky called the meeting to order at 9:30am. The meeting began with a presentation by representatives from LCC who presented a proposal to offer weekend classes during the summer that could be structured to meet the needs of the group. → Doug Koons reported an end of month balance of \$15,902 and a net income for the year of \$907. A motion was made and passed to accept the Treasurer's report. A motion was also made and passed to accept the minutes of the last meeting as reported in the newsletter. →Joe Pirch reported on his findings of the audit for the year ending on Dec 31st 2006. In summary, he reported that the financial statements looked good but recommended that we inventory and record the Chapter assets. →Doug Koons reported on Young Eagle events for this year and awarded the credit points and certificates to the 2006 Young Eagle pilots. He also reported on the new light fixtures. The cost of the materials equaled the cost of purchasing two replacement light, according to Doug. →Bill Bezdek reported on the Dayton trip. Bill Purosky reported that we made about \$650 profit for putting on the Garmin/Beacon Aviation seminar dinner. →The CRAA sponsored Airport Advisory Group was discussed. This group will assist CRAA with formulating Mason Airport rules and regulations. Several members of the Chapter are instrumental in getting CRAA to create this group and the Chapter will likely be represented with one or more members appointed to the Group. →The membership was reminded that it is not too late to sign up for MAD work assignments. →May 19th is the Teacher's Aviation Conference. →Members are encouraged to write their Congressmen regarding proposed FAA funding proposals. Bill Purosky volunteered to write a custom letter for anyone. EAA and AOPA both have suggested letter language on their respective web sites. →The meeting adjourned at 10:43.

Notes from Cape Juby

Here is a story about some truly heroic aviators. I hope some of you heard about this from other sources, but I learned of it only recently through an article in Aviation Week magazine. The U.S. Coast Guard Crew flying an HH-60J received the Breitling Award for Aviation Heroism. Here is the story.

On March 14, 2006 someone decided it was a nice day to do a solo climb (as in alone, see ya Suzie, I'll be home for dinner....) of Devils Thumb in Alaska. Rising 9,077 feet, Devils Thumb (no apostrophe in the official name) is one of the more difficult climbs in the Stikine Icecap region along the Alaska-British Columbia border. Checking the calendar, it should be noted that March 14th is indeed, still winter, particularly in that part of North America. Why Zac Hoyt decided to attempt the climb in the middle of March rivals the age old question of why did the chicken cross the road.

To his climbing skills credit, Zac actually made it to the top, and was on his way down when he fell into a crevasse at the 5,000 foot level. Although he managed to crawl out, he was

injured and couldn't reach the shelter of his tent. Fortunately, he had a radio and was able to initiate a rescue attempt. The Coast Guard dispatched the helicopter from Sitka, Alaska with pilots William Timmons, and Walter Horne, flight mechanic Karl Schickle, rescue swimmer John Houlberg and a three man mountain rescue team.

When the helicopter arrived above the glacier just before sundown, visibility was 1 mile in blowing snow with winds of 45 gusting to 60 knots. They hovered 1000' above the ice and were lucky to spot the climber's yellow tent through a break in the snow. The crew marked that position in the nav computer and continued to search. Hoyt radioed that he could hear the helicopter but couldn't see it. Conditions were far too hazardous to deploy the rescue team.

The crew made several passes in the approaching darkness, but couldn't locate the climber. Despite severe turbulence and limited visibility, they decided to make one more pass. Using the tent and two crevasses as a reference, they let down to 100' above the ice, and slid open the door to the sting of wind blown air at -20F, and an equivalent wind chill of -100F. It was a life and death move for both helicopter crew and climber.

With his visor frosting over, and eyes watering in the intense cold, Karl Schickle operated the winch and lowered a rescue basket to the ice below. The climber saw it and managed to crawl inside, but in the wind and ice, the basket caught on an ice pinnacle and flipped on its end. Hoyt managed to stay inside and Schickle began hoisting the basket with a nearly frozen winch.

Both pilots had to fly to maintain control of the helicopter as they made their way down the glacier. Some of the avionics had frozen and were not working. The intercom had failed. They were in IFR conditions most of the time. Their first two landing attempts were waived off because of blowing snow. In the end, they landed safely, saving a life after testing man and machine to the absolute limits. Wow!

I am also reporting the timely death of Neville Duke, a British fighter pilot from WWII who later became a noted test pilot. Usually deaths are reported as untimely, but this story has a slightly different twist.

Neville Duke flew during the Battle of Britain, with one kill against an Me-109. He was then posted to North Africa where he flew most of his combat missions. He flew the P-40 and then later marks of the Spitfire. He became Britain's leading Ace in the Mediterranean area, with 28 aircraft destroyed. Shot down, he spent some time as a guest with the Italian underground.

After WWII, there was intense activity in both the U.S. and Britain to develop a supersonic jet fighter. We all know of Chuck Yeager, the X-1, and the development of the F-86, which could go supersonic in a dive. But here in the U.S. we may not have heard of the development of the Dh110 and Hawker Hunter. After attending the Empire Test Pilot School in England, Neville Duke became Chief Test Pilot on the Hawker Hunter. He did all the development flying, and in September 1953 flew it to a world speed record 727.6 mph.

At the Farnborough Air Show the following year, he was on the ramp ready to climb into the Hunter and watching pilot John Derry and his navigator Anthony Richards as they broke the sound barrier in the Dh110. But tragedy struck as the airplane broke apart, killing both men and 28 people on the ground. Minutes later, Duke took off and climbed to altitude and put the Hawker Hunter into a 40 degree dive and 50,000 fpm descent to create a sonic boom that reverberated around Farnborough. Can you imagine the multiplicity of thoughts going on in his mind?

On April 7th, 2007 Neville Duke was flying along with his wife Gwendoline on a sunny day in England and mentioned that he wasn't feeling quite well. He made a normal landing but couldn't climb out of the airplane. Neville Duke died as he reached the hospital. If one's passing were ever to be described as timely, this would be the example.

Speaking of examples, I want to thank Bill Purosky, Doug Koons, Tom Botsford, Jack Toman and whoever else helped my Dad and I move from one hangar to another last week. A job that I expected to take one rather tiring day took just two hours and we were finished in time for lunch! Help like that is what makes aviation tick. Thanks, guys!

The weather was pretty good last week, with east winds that mostly behaved itself, although there were some striking bumps in the air. There is a lot of flying ahead, so fly safe, and don't forget that sometimes aviators need a tiny bit of help, so don't forget help when you can.
